They are intended to be suggestive, not only to the teacher, but to independent students and young newspaper workers. A bibliography has been added to suggest further reading. In the schools of journalism, the methods of teaching copyreading have developed during the period since first publication probably more than any other branch and have been somewhat standardized.
