Specifically, comparing regulatory and supervisory practices before and after the global crisis, the paper finds relatively few changes: capital ratios increased (primarily among non-crisis countries), deposit insurance schemes became more generous, and some reforms were introduced in the area of bank governance and bank resolution.

The main finding of the paper is that there is a positive correlation between the preferential regulatory treatment of certain exposures for regulatory capital purposes and the surge of interest in such exposures (collateral) to be used in repo transactions. The preferential regulatory treatment of certain repo collateral (domestic government bonds) in terms of capital requirements and repo haircuts can also partly explain the home bias and bank-sovereign loop in the European banking and financial markets.
