At Ballou Senior High, a crime-infested school in Washington, D.C., honor students have learned to keep their heads down. Among the mere handful of students with a B average or better, some plead to have their names left off the "Wall of Honor" bulletin board; others hide during awards ceremonies; only a few dare to raise their hands in class. Like most inner-city kids, they know that any special attention in a place this dangerous can make you a target of violence. But Cedric Jennings, the lanky son of a jailed drug dealer, will not swallow his pride, though each day he struggles to decide who he wants to be. With unwavering support from his mother, he studies and strives as if his life depends on it--and it does. The summer after his junior year, at a program for minorities at MIT, he gets a fleeting glimpse of life outside Ballou--an image that burns in his mind afterward and fills him with a longing to live in such a world. In his senior year, walking a gauntlet of sneers and threats, he achieves a 4.02 grade-point average and then the impossible: acceptance into Brown University, an Ivy League school. At Brown, finding himself far behind most of the other freshmen in his academic training and his knowledge of broader culture, Cedric must manage a bewildering array of intellectual and social challenges. Cedric had hoped that at college he would finally find a place to fit in, but he discovers he has little in common with the white students, many of whom come from privileged backgrounds and party hard while acing tests. Even the middle-class blacks have trouble understanding Cedric, a straight-arrow church kid from the ghetto who seems like an obvious product of affirmative action. As he struggles to master classwork and think like a scholar, he realizes that faith alone can take him only so far.
